The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

Terms and Conditions (As per GeM)

1. General Terms and Conditions-

1.1 This Contract between the Seller and the Buyer, is for the supply of the Goods and/ or Services , detailed in the schedule above, in accordance with the General Terms and Conditions (GTC) as a vailable on the GeM portal (unless otherwise superseded by Goods / Services specific Special Term s and Conditions (STC) and/ or BID/Reverse Auction Additional Terms and Conditions (ATC), as app licable

1.2 Terms of delivery: Free Delivery at Site including loading/unloading. 1.4 Performance Security: If the Seller fails or neglects to observe or perform any of his obligations under the contract it shall be lawful for the Buyer to forfeit either in whole or in part, the Performa nce Security furnished by the Seller.

1.9 Liquidated Damages: If the Seller fails to deliver any or all of the Goods/Services within the ori ginal/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recov er the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid , @ 0.5% per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value without any controversy/dispute of any sort whatsoever. In case, Servic e Level Agreement (SLA) is applicable the same shall be applicable for the Contract.

1.10 Financial Certificate:
