## MSWC Minutes held on 9<sup>th</sup> August, 2015

The following issues were discussed in MSWC meeting that was held on 9<sup>th</sup> August, 2015:

#### 1. Ratification of minutes of MSWC meeting held on 23th June 2015

There were no corrections in the draft minutes. Minutes were finalized and will be uploaded on website.

#### 2. Request given by an MSWC member for resignation

Mr. Anand Mehta (BR-GH) has given a request for resignation, which was accepted by committee. From now on Mr. Pramod Soni (G-5) will serve as Block Representative for GH block.

#### 3. Independence day celebration in SBRA

Independence Day will be celebrated in SBRA for which budget of 30,000 is allocated.

#### 4. Request given by a resident for changing house

Mr. P.R. Krishna Mohan (L-3) requested for changing his house. As per his request "he has two children about 3.5 years and 5.4 years of age and they are not in a position to express any unfortunate incident that may take due to snake bite. Moreover their mother tongue language is Telugu and children will not be able to communicate regarding any such incidents to other people in their absence." Understanding his request committee decided that he will be allotted next vacated house in old SBRA.

#### 5. Installing RO purifier in SBRA


Warden Sir informed committee that permission for RO is granted from deputy director, if we can install RO purifiers in SBRA, using MSWC budget and will have to be maintained by MSWC only. MSWC will spend 70,000 Rs for purchasing 2 RO purifiers (1 for new and 1 for old SBRA). Both purifiers will be installed at present RO locations (Y block water cooler in new SBRA, water cooler in old SBRA) only.

## 6. Status of implementation of decisions taken by MSWC

- **“Decision raised on eligibility of Mr. Burra Gunashekhara as SBRA resident”**: The issue was again discussed and it was decided that Mr. Burra Gunashekhara will have to vacate SBRA by 20<sup>th</sup> August. Upon Warden Sir’s recommendation, considering a special case he will be put in priority list of SBRA waiting list. As soon as he gets married, he will be re-allotted SBRA.
- **“Removing old SBRA SIS guard issue”**: Warden Sir informed us that this issue is under consideration by concerned authorities in institute.
- **“Removing name of waiting list candidates with insufficient documents”**: Few waiting list candidates who were not married within 4 months of applying for SBRA were removed from waiting list. Couple of them requested for reinstating their name. The issue was discussed by committee and their request was denied. They will have reapply after producing marriage certificate.

## 7. Grass cutting rate in old SBRA

Grass cutting rate is increased from 30 Rs to 40 Rs affecting from 9<sup>th</sup> August, 2015.
